ELIGIBILITY:** The Super Saturday Night Locker Giveaway (the “Promotion”) is open only to legal residents of the United States who are 18 years of age or older at the time of entry and who attend Super Saturday Night on February 2, 2019, at Atlanta Station, 1371 Market St NW, Atlanta, GA. Employees, officers and directors of High Hat Productions, Inc. (the "Sponsor"), Zenith Touring, Inc, AT&T, DIRECTV, their parent companies, subsidiaries, affiliates, advertising agencies, and promotional suppliers (collectively, "Promotion Entities") and the immediate family members (spouses and parents, children and siblings and their spouses, regardless of where they live) or members of the same households (whether related or not) of such individuals are not eligible. - 2. TO ENTER:** The Promotion will be offered between the hours of 7:30 PM Eastern Time (“ET”) and 10:30 PM ET (the “Promotion Period”) at the Super Saturday Night registration kiosk. Before you can participate in the Promotion, you must register at the kiosk and receive your validated wrist band. You may then proceed to the Super Saturday Night Locker Giveaway area where you will select a key to open a locker. Insert the key into a closed locker and open to reveal your prize (subject to verification and compliance with these Official Rules). Most prizes will be fulfilled immediately on-site. For others, a voucher describing the prize and directions for claiming it will be provided. A total of 5,057 prizes will be available. See Section 3 for prize descriptions, approximate retail values, and odds of winning (“Odds”). Promotion will end once all prizes have been awarded or by 10:30 PM ET, whichever occurs first, Unclaimed prizes, if any, will not be awarded. **Limit one prize per eligible person.** In case of a dispute about any prize or prize winner, decisions of the kiosk personnel will be final in all regards.
